- G. To borrow money from bank and other financial institutions or persons to mortgage property of the trust for raising of the funds to fulfill the object of the trust.
- H. The Trustees also have a right to donate or contribute any of the trust fund to any trust or institution, society etc the object of which are the same or likely to be the same of the trust.

9. MEETINGS:-

The board of trustees hold at least 2 meetings annually, one of which shall be annual meeting wherein the budget of that year and expenditures of the previous year shall be submitted.

The meeting shall be called by the president of board of trustees. Ten days notice by personal notice or by registered post of the meeting shall be necessary. The secretary of board of trustee shall cause a minute book of the proceedings of the meeting of board of trustees to be maintained.

That it is reiterated that board of the trustees of the BRIJENDRA SINGH SAHNI EDUCATIONAL TRUST shall be supreme governing body of all the institutions, which shall be established under this deed i.e. institution, hostel boarding house etc established or run by a committee and management of various institute and colleges. Hostel established by the board trustee shall work under supervision, control and direction of the Board of Trustee. No person or body shall have the power to alter this supremacy.

The Board of Trustees shall have the power and discretion to accept any donation or contribution whether such donation or contribution be in cash or in form of immovable or movable property from any person, government, local authorities or any other charitable institutions.

**10. POWER & DUTIES OF THE TRUSTEES:-**

The trustees shall purchase piece of land and shall erect a building suitable for educational institutions, technical educational institution, colleges, boarding houses and hostels according with the plan passed by the competent authority.

The trustees shall employ such staff as they think necessary to run the organizations set up it on such salaries as they think fit and replace them whatever they think necessary. The trustees shall also employ and remove other servants which they consider for the purpose, set off the income of the trust fund; the trustees shall defray the expenses for running educational institutions, technical educational institution, colleges, boarding houses and hostels as aforesaid and expenses for acquiring premises for educational institutions, technical educational institution, colleges, boarding houses and hostels but if income is insufficient for that purpose, the trustees may use such portion of corpus of the trust fund as may be necessary.

The trustees shall have the power to borrow money on the security of the trust property and to alienate the trust property for necessary purpose.

The trustees may invest the surplus fund by their hands in such

H. MANAGEMENT:-

- (a) The Board of trustees shall frame the rules of management of the institutes, colleges and other institutions established and run by the trust. The board of trustee's shall have the right to make such amendment, modification, addition, substitution in rules of management of such institute as it deems fit from time to time. BRIJENDRA SINGH SAHNI EDUCATIONAL TRUST is authorized to make such amendment, modification, substitute additional alterations in the rules of the other institutions as it deems fit and to fulfill the statutory requirements and conditions of the educational bodies or universities.
- (b) The management and administration of the trust, of the properties and affairs of the trust shall vest in the founder trustees or the persons nominated/authorized by them and they will exercise all such powers and do all such acts deed as may be necessary to conduct the affairs of the trust. The founder trustees will be life-time trustees. Their rights will not be challenged by any nominated/authorized person as trustees.
- (c) In the case of death of any person among founder trustees, the other founder trustees and further his family members will get the authority of nominating the trustee.
- (d) After the foundation of trust only the President will have right to alter increase or decrease number of members.
- (e) Ultimately the wholsome power will be vested within the authorization of president.
- (f) If any member remains inactive or works against trust he/she can be expelled with the consent of board members and final decision will be of president.
- (g) The starting amount of the trust is Rs. 11000/-

**12. RIGHTS AND DUTIES OF THE PRESIDENT:-**

The President will be the head of the all meetings of board of trustees and he can arrange meeting with his written permission. Board of trustees can not be called in absence of President. In such condition if he deems it necessary the Secretary is authorized to exercise all the powers of board of trustees and any decision taken by him on behalf of board of trustees will be deemed as taken by board of trustees till the convening of the turgent meeting of board of trustees within 15 to 30 days. If President exercises all the powers of board of trustees in emergency then that opinion of President is not alone opinion, opinion must be by general Secretary in writing. All decision of the President consented with general secretary.

**13. RIGHTS AND DUTIES OF GENERAL SECRETARY AND TREASURER:-**

The secretary will call the meetings with or without previous permission of the President and meeting can not held in the absence of general secretary. A meeting called by either General Secretary or President. It shall be the duty of the secretary to maintain a meeting of the board member and enter minutes of all the proceeding at such meeting in the note book. A copy of any minutes of any resolution or other act or proceeding of the trustee certified in writing by the secretary for the time being of the trustees to be a true copy thereof shall be conclusive evidence for all purpose.

**15. ACCOUNT:-**






